- work in partnership with our suppliers to ensure effective environmental supply chain management and to promote sustainable sourcing of products and materials
- promote good driving practice
- use only timber that is certified as derived from legal and sustainable sources whenever it is practicable to do so
- maintain liaison with the local communities in which we work

Arrival Electronics will review this policy annually to take into account changes in the organisation, legislation or any other external factors.
